

GENERAL INFORMATION

The sanctioned classes are listed in the 2025 Vermilion Fair Book and online in Showorks (vermilion, fairwire.com).

STOCK TRAILER & RV PARKING

Camping is available on-site for exhibitors ONLY, but availability is limited. 1 power site per exhibitor family as they are limited. RV site with power \$20/day. RV site with NO power \$10/day. Please request RV site on entry form. Sites are held only with payment. For RV power stall, priority is given to multiple day exhibitors or for special needs. Generators may be used in non-power stalls. For all camping inquiries, please contact the Vermilion Agricultural Society Office at 780-853-4108. Loading of unloading of livestock will be allowed in front of the buildings where stalls are located, but vehicles must be removed immediately after the last animal is taken off the trailer. **Animal Trailers will be parked off-site, in designated zones.**

VEHICLE PARKING

Limited vehicle parking in the designated parking zones. All passenger vehicles must be parked in the designated parking zone, violators will be towed at the owner's expense. All license plates must be registered with the Vermilion Agricultural Society Office and included on the exhibitor's entry form.

INTERPRETATION

- 1 Throughout the Competition Rule Book, Vermilion Fair of Vermilion Agricultural Society shall be referred to as the "VAS" or the Vermilion Fair.
- 3 "Directors" means the Board of Directors or the Executive of the VAS.
- 4 "Judge" means the person(s) contracted by the VAS to decide placings at events, competitions, shows at such the Vermilion Fair.
- 6 "Exhibitor" means any owner signing an Entry Form and/or the Lessee, manager, agent, nominator,
- driver, rider, or employee of such owner.
- The VAS Management has the final and absolute right to interpret these rules and regulations and to
- 9 determine all matters, questions or differences in regard thereto, or otherwise arising out of, or in
- 10 connection with, or incident to the VAS.
- 11 VAS Management has the right to amend or add to these Rules and Regulations from time to time.
- 12 Any exhibitor who violates any of the rules and regulations printed in the Competition Book will forfeit all
- privileges and premiums upon the decision of the management.

This may include any or all the following:

- 1 prizes and awards
- 2 prize money
- 3 forfeiture of any or all passes, entry fees and stall rental fees.

ENTRY PROCEDURE

- 1 Exhibitors are encouraged to place their entries online where applicable.
- 2 An entry will be considered valid only when the VAS receives a properly completed and signed Entry Form including payment in full by no later than the entry closing date. The VAS reserves the right to refuse any entry fee without further liability. Closing dates are stated in each competition section.
- 3 Payment of entry fees will be accepted by MasterCard/Visa, cheque or debit/cash.
- 4 Exhibits that have been erroneously entered, may, at the discretion of the Committee Head, be transferred to their proper classes prior to judging.
- Unless otherwise specified no entry is required for championships or specials, provided the animal or article is entered in the appropriate regular class. First and second prize winners are automatically eligible for championship.

GENERAL INFORMATION

EXHIBITS

1 All Exhibits shall be under the control and direction of the VAS but solely at the risk of the exhibitor. The VAS will not be responsible for damage, injury, loss of theft of any exhibit, irrespective of the cause of such damage, injury, loss, or theft occasioned by or arising from any article exhibited by him/her and shall indemnify the VAS against all legal or other proceedings in regard thereto.

EXHIBITOR CONDUCT

- 1 Any false representation interference or unacceptable conduct on the part of an Exhibitor will be dealt with by the VAS according to the circumstances of the case.
- Upon discovery of any fraud, deception or dishonest practice, either in the preparation or ownership or of any misrepresentation concerning any article exhibited, which may have affected or have been intended to affect the decision of the judges, the Executive Committee has the power to withhold the payment of any prize awarded.
- 3 Smoking is PROHIBITED in the barns and indoor areas.
- 4 It is the responsibility of each exhibitor to keep stalls, pens and/or exhibit area clean and neat and professional displays are encouraged. Space visible to the public and/or your neighboring exhibitors must be finished attractively.

EXHIBIT JUDGING

- 1 Judges are expected to familiarize themselves with all the rules and regulations of the Vermilion Fair and to particularly note those bearing on the classes to be judged by them.
- 2 In the absence of competition in any class, the judge will award such premium as he/she determines the exhibit deserves. He/she will exercise his/her discretion as to whether first, second or any premium will be awarded. Judges may not award prizes to unworthy exhibits.
- 3 If there is any question regarding the legitimacy of an entry, or the right of an article to compete in any Section or Class, the judge shall report this to the Committee head in charge.
- 4 All judging documentation (each page initialed) must be signed with the judge's regular signature and returned to the VAS Show Office as soon as the awards are completed. Judges should not leave the Vermilion Fair until they have ascertained that there are no protests any of the areas in the classes they have judged.
- The decision of the judges shall be final in all cases. However, should an exhibitor have a protest, the procedures for a protest of that competition section are applied.
- Any exhibitor who by himself/herself interferes or shows disrespect to any judge during the performance of his/her duties on the premises occupied by the VAS or is guilty of conduct calculated to bring the VAS into disrepute shall be subject to any or all the forfeitures and/or penalties provided for in INTERPRETATION Rule #7.

AWARDS

- 1 Prize money will be dispersed as per the competition section an award is given. All prize money is payable in Canadian Funds.
- 2 Each exhibitor shall agree that photographs taken of the exhibitor and/or exhibits by any photographer approved by the VAS or its official sponsors have commercial usage rights.



GENERAL INFORMATION

Rules and Regulations

- 1 All entries must be RECEIVED by July 16, 2025. All entires must be paid in fill before judging starts.
- 2 All registered Heavy Horses competing for prizes must be owned and registered in the name of the exhibitor at the date of competition and certifications of registration of ownership must be produced to the Show Committee or the Director in charge of the class if called for.
- 3 No exhibitor shall show the same animal in more than one class or more than one section of a class, except in
- 4 team or special classes
- Animal entered in Youth classes are eligible to compete in the regular classes at he same exhibition, subject to the
- 6 usual entry fee being charged
- 7 No purebred animal can be shown in any section or class other than its own, except where specifically stated in the show book
 - Entry fees will not be refunded under any circumstances unless a Veterinary Certificate is presented to the Secretary or Manager no later than 48 hours after the show.
 - Judges decisions are final. When there is only one exhibitor in a class, first place prize if merited, will be awarded. When entries are not worthy of first prize, judges may, at their discretion, award a prize or prizes such grade as the entry merit.
- All prize money will be mailed out to the winning entries after the Fair. Junior Showmanship exhibitors will receive
- their prize money inthe form of cash after their respective classes.
- No vehicles are allowed on the grounds violators will be towned at the owner's expense
- 10 SCHEDULING: In the case of unforeseen circumstances (i.e) number of entries, scheduling could be altered by the Heavy Horse Committee.

<u>Liability:</u> All exhibitors shall be under the control and direction of the Vermilion Ag Society but solely at the risk of the said exhibitor. The Vermilion Ag Society will not be responsible for damage, injury, loss or theft of or to any exhibit, irrespective of the cause of such damage, injury, loss or theft. Each exhibitor will be solely responsible for any loss, injury or damage done to, administered by or arising from any animal or article exhibited by him/her, for its description as given in the catalogue. This shall indemnify the Vermilion Agricultural Society against all legal or other proceedings regarding it.
